Shavkat Mirziyoyev, In His Speech, Said That "The Flourishing Of Our Planet Depends On What Kind Of Children We Grow Up To. Our Main Task Is To Create The Necessary Conditions For Youth To Show Their Potential".

Also, The Adoption Of The Law "State Policy On Youth" On September 14, 2016, And The "The Strategy Of Actions For Further Development Of The Republic Of Uzbekistan" Became A Crucial Legal Basis In Educating Young People As Purposeful, Self-Sufficient, Patriotic, Loyal, And Competent Persons.

During The Last Four Years In Uzbekistan, The Attention To Youth Has Increased, The Issues Of Their Broad Involvement In Culture, Art, Physical Education, And Sports, The Formation Of Skills In Using Information Technologies, The Promotion Of Reading Books Among The Youth, The Increase Of Women's Employment Have Risen To The Level Of The State.

The Agency For Youth Affairs Is A State Governing Body That Develops And Implements State Policy On Youth, Carries Out Measures Aimed At Creating Conditions For The Development Of The Potential Youth In Social, Creative, And Other Spheres. In The Republic Of Karakalpakstan, In The Regions, And Tashkent, The Agency Departments Were Organized. When President Shavkat Mirziyoyev Said That

The District (City) Council Of Relevant People's Deputies Content To The Audience, They Will Have An Excellent Opportunity To Be Elected.
